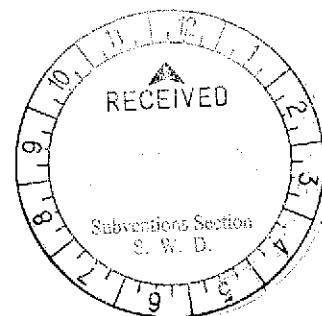

**Proposed Project Outline**

**Specialist Centre for Adolescents and Adults with Autism**

**Target group:**

The target clients are adolescents and adults with a diagnosis of autism or autistic features, who are aged 11 or above and their family. The general public is also our target for community education on better understanding of persons with autism. The centre also serves as a base for training and research on autism service in Hong Kong.

**Time Schedule:**

The service is planned to be started in September 2005

**Brief Content:**

Rationale and Objectives

Persons with autism have unique characteristics including impairment in social interaction and communication, repetitive and stereotyped patterns of behaviours etc. They are in need of specialized programmes and training that are different from normal persons and persons with mental retardation. Unfortunately, at present, persons with autism are normally placed in Day Activities Centres for persons with mental handicap, the training in which are not suitable for them, while many remain in open employment without suitable assistance and end up idling at home.

The proposed autism service center is to provide a structured, autism-friendly environment for persons with autism for learning and development. The center will tailor-make specialized programmes to help persons with autism to achieve maximum independence and to learn to adjust to their own home, school or working environment so that they become active members of the community. The center will also support parents and family members to handle challenging behaviours of persons with autism. It will be a centre for rehabilitation professionals to exchange and build up knowledge and consolidate experience on autism service for future development of the autism field in Hong Kong.

### Services and Programmes

The center will provide Day Programmes, After-School Programmes, Weekend Programmes, Summer Programmes and Clinical Services for persons with autism. The programmes include training on life skills, vocational skills, social and communication skills, recreational activities, adaptive physical education etc.

Training and educational programmes and workshops for rehabilitation professionals, school personnel, volunteers, parents and other family members, helpers.

In-Home Consultation, Support Groups for parents and siblings of persons with autism, Support to schools to facilitate inclusive education of persons with autism.

Volunteer programmes and community education programmes to provide friendship between persons with autism and members of the community.

Resource Centre and Library.

### No. of Persons to be Benefited

We estimate a minimum of 1660 attendance for the client-oriented services per year, and we estimate a minimum of 600 parents / caregivers, professionals, school personnel, and members of the general public participating in various family- and community-oriented services per year.

### Other factors for the consideration of business corporations

Persons with autism are offered opportunities to apply what they have learned in a real, functional situation. They are assisted and encouraged to integrate in the community as active and independent members. Staff of business corporation are welcomed to give financial support to the centre, to provide work placement to persons with autism or to be volunteers of the centre.
