5. Knowledge and Skills of Staff Members on Infection Control

6. Infection Control Measures

- (a) Observe and record the conditions of residents every day
- (b) Take body temperature for residents with special health conditions regularly
- (c) Dedicate the same team of staff members to take care of a fixed group of residents and work in the same area as far as possible
- (d) Record the basic information and visiting dates of all visitors
- (e) All staff do perform hand hygiene, wear gloves and masks properly or put on other appropriate personal protective equipments when taking care of residents
- (f) All staff did perform hand hygiene properly before and after caring for each resident
- (g) All residents, staff or visitors with respiratory symptoms do wear surgical masks

7. Information on Infection Control

- (a) Disseminate and explain the most updated guidelines on prevention of communicable disease to staff members
- (b) Post a notice/poster on prevention of communicable disease at prominent locations
