**Review Report on the  
Lump Sum Grant Subvention System (LSGSS)**

I refer to our letter dated 22 May 2009 on the captioned subject and would like to obtain information from your organisation on implementing the Recommendation 28 of the Lump Sum Grant Independent Review Committee (LSGIRC), i.e.

*A formal public accountability framework should be in place for NGOs to disclose their AFRs as submitted to the SWD, so that they will also be accountable to the public for the proper and prudent use of public funds. To meet the requirements as suggested by LSGIRC, NGOs should establish their channels of disclose of AFR to public and disclose the AFR to public upon their submission of AFR to SWD to each year, including:*

- *posting up a copy of AFR to their notice board(s) at the Central Administration Unit/ Head Office;*
- *uploading to website;*
- *placing the AFR into their Annual Report; and*
- *issuing special circular, newsletter or whatever means to provide the content of AFR and should be made available to public upon request etc.*

I should be grateful if your organisation would provide your actions taken in relation to this recommendation by completing the attached form and return it to us **by 25 March 2010**. Please note that information collected from your organisation will be used for reporting the progress to the Lump Sum Grant Steering Committee and Legislative Council in aggregate terms.
