Brief of Application for Joining Bought Place Scheme for Private Residential Care Homes for Persons with Disabilities (Bought Place Scheme)

The Social Welfare Department (SWD) has implemented the Bought Place Scheme (BPS) since 2010 so as to encourage private residential care homes for persons with disabilities (RCHDs) to enhance their service standards and increase the supply of subsidised residential places in order to shorten the waiting time for the residential care service and provide more service options for persons with disabilities. At present, SWD has purchased about 700 places of high level of care and about 620 places of medium level of care from 20 private RCHDs with licenses.

Extending the BPS to Self-financing RCHDs operated by Non-governmental Organisations (NGOs)

To widen the supply of subsidised places and provide more service options for persons with disabilities, the SWD has extended the BPS to self-financing RCHDs operated by NGOs¹. The operators of self-financing RCHDs may submit applications if the RCHDs meet the space, staffing and service quality standards, etc. as required by the BPS.

Bought Place Scheme

The SWD plans for purchasing additional places of the **High Level of Care** (Category 1) and the **Medium Level of Care**. The operators of eligible RCHDs may submit applications. The SWD will conduct vetting on the service quality and performance of individual RCHDs to ensure that the RCHDs meet the requirements.
