Service Description 服务简介





社会福利署(社署)透过资助非政府机构,营办8个短期食物援助服务 队,在全港为难以应付日常食物开支的个人及家庭,提供一次过一般 不超过8个星期的基本食物援助,其中包括乾粮、食物券及热食券。

The Social Welfare Department (SWD) has commissioned non-governmental organisations to operate 8 Short-term Food Assistance Service Teams (STFASTs) to help individuals and families who have difficulties in coping with their daily food expenditure throughout the territory. Service users normally receive one-off in-kind food as well as food and hot meal coupons for a period not exceeding eight weeks.



Target Groups 服务对象





未能应付日常食物开支的个人或家庭,包括失业人士、低收入人士、 新来港人士、露宿者,以及因遭逢突变而有即时经济困难人士等。申 请人及住户成员的每月入息及资产总值不得超过短期食物援助服务所 定的限额。自住物业并不计算在资产限额中。

Individuals or families who have difficulties for coping their daily food expenditure, including the unemployed, low-income earners, new arrivals, street sleepers, as well as those encountering sudden change and facing immediate financial hardship, etc. The monthly income and total value of the assets of the applicants and household members shall not exceed the prescribed limits of the Short-term Food Assistance Service. Self-occupied properties are excluded from the calculation of the asset limits.

Application Procedures 申请办法

申请人可联络服务其居住地区的短期食物援助服务队,并提供身 份证明、住址证明及经济证明等资料,供服务队审批。

Applicants may contact the STFASTs according to their place of residence and provide the STFASTs with identification, residential and financial proof, etc. for eligibility assessment.
