Remarks:

* In response to the enhancement of vocational rehabilitation services, all sheltered workshops have been upgraded to Integrated Vocational Rehabilitation Services Centres with effect from 1 October 2025.
The Integrated Vocational Rehabilitation Services Centres do not have a central waiting list. Referrers can make referrals through the Central Referral System for Rehabilitation Services of the Social Welfare Department. For application of supported employment services in the Integrated Vocational Rehabilitation Services Centres, referrers or applicants can also approach the service units direct.

Note 1 The number of applicants on the waiting list as shown at this report includes those whose applications are being processed for admission but not yet admitted at the time of the reporting.

Note 2 The number of waitlisted applicants as shown includes (i) applicants who have applied for DAC service only; and (ii) applicants who have applied for DAC & Hostel services and indicated readiness to accept DAC service first while awaiting Hostel service.

Note 3 The number of waitlisted applicants as shown includes only applicants who have applied for DAC & Hostel services and requested allocation of both services at the same time.
