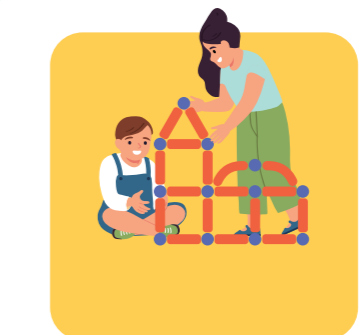

Applying for subvented pre-school rehabilitation services is free of charge. The applicant should report to the Independent Commission Against Corruption (ICAC) immediately if anyone offers to assist in the application for placement in return for remuneration. Attempted bribery by any person is also an offence under the law, and SWD will refer such cases to ICAC for investigation.
