- Note 1: The annually revised income ranges in the table in different co-payment categories are based on Median Monthly Domestic Household Income (MMDHI) of the third quarter of 2024.
- Note 2: It is also applicable to those who do not wish to be subject to means test.
- Note 3: The co-payment amount in between the ceiling and floor voucher values is calculated according to the voucher value used for purchase of service package and the respective co-payment percentage of the voucher holder. (rounded to the nearest dollar)
- Note 4: Since 2025-26, the recognised service providers (RSPs) are allowed to set their own floor voucher value which should not be higher than the recognised floor value set by the Social Welfare Department. The minimum co-payment amount would be adjusted according to the floor value set by the respective RSPs.
