

Community Service Orders Scheme 社會服務令計劃

Service Description 服務簡介

Community Service Order (CSO) is a community-based sentence pursuant to the Community Service Orders Ordinance (Chapter 378, Laws of Hong Kong). A court may make an order requiring a person of or over 14 years of age and convicted of an offence(s) punishable with imprisonment to perform unpaid work for a number of hours not exceeding 240 hours within a period of 12 months.

社會服務令是根據《社會服務令條例》(香港法例第378章)的社區層面判刑。法庭可向14歲或以上干犯可判監禁罪行人士判處社會服務令，要求接受社會服務令人士(下稱「服令者」)，在12個月內完成不超過240小時的無薪社會服務工作。

Service Target 服務對象

- Offenders referred by the courts for social enquiry
- Offenders ordered by the courts to be put under CSO
- 由法庭轉介須接受社會調查的違法者
- 由法庭判處社會服務令的違法者

Service Scope 服務範圍

- Preparing Suitability Reports for Community Service Orders in serving the courts
- Arranging unpaid community work placement for offenders put under CSO, with on-the-spot supervision, technical instruction and practical guidance on various types of work provided
- Providing statutory supervision, guidance and counselling to offenders put under CSO through regular interviews and other activities
- 為法庭撰寫社會服務令報告
- 為服令者安排無薪社會服務工作，並就各類工作提供實地監管、技術指導及實務指引
- 透過定期會面及其他活動，為受感化者提供監管、指導及輔導

Service Entry and Exit 申請及退出服務

All service users are referred by the courts. Entry and exit of the service are bound by respective ordinance.
