

Community Service Orders Scheme 社会服务令计划

Service Description 服务简介

Community Service Order (CSO) is a community-based sentence pursuant to the Community Service Orders Ordinance (Chapter 378, Laws of Hong Kong). A court may make an order requiring a person of or over 14 years of age and convicted of an offence(s) punishable with imprisonment to perform unpaid work for a number of hours not exceeding 240 hours within a period of 12 months.

社会服务令是根据《社会服务令条例》(香港法例第 378 章)的社区层面判刑。法庭可向 14 岁或以上干犯可判监禁罪行人士判处社会服务令, 要求接受社会服务令人士(下称「服令者」), 在 12 个月内完成不超过 240 小时的无薪社会服务工作。

Service Target 服务对象

- Offenders referred by the courts for social enquiry
- Offenders ordered by the courts to be put under CSO
- 由法庭转介须接受社会调查的违法者
- 由法庭判处社会服务令的违法者

Service Scope 服务范围

- Preparing Suitability Reports for Community Service Orders in serving the courts
- Arranging unpaid community work placement for offenders put under CSO, with on-the-spot supervision, technical instruction and practical guidance on various types of work provided
- Providing statutory supervision, guidance and counselling to offenders put under CSO through regular interviews and other activities

- 为服令者安排无薪社会服务工作, 并就各类工作提供实地监管、技术指导及实务指引
- 透过定期会面及其他活动, 为受感化者提供监管、指导及辅导

Service Entry and Exit 申请及退出服务

All service users are referred by the courts. Entry and exit of the service are bound by respective ordinance.
