Foreword

The Child Protection Registry (CPR) has been computerised and administered by the Family and Child Welfare Branch of the Social Welfare Department (SWD) since June 1994. Functions of the CPR include case registration, case checking and provision of statistical information on registered cases involving children having been harmed/maltreated or currently at risk of harm/maltreatment. Service units of both SWD and Non-Governmental Organisations (NGOs) may register cases handled by them with the CPR. Following the review of the CPR and the revision of the data input forms adopted for reporting child protection cases to the CPR, the CPR was further enhanced in September 2022 to capture more information on the cases.

Since 1996, statistical reports on the CPR have been published on an annual basis to provide general information and demographic data on registered cases involving children having been harmed/maltreated or currently at risk of harm/maltreatment in the year. This report, “Statistical Report 2025”, consists of two parts. Part 1 is on the cases registered in 2025 and Part 2 is on a comparison of newly registered cases from 2023 to 2025. In each part, general information on the cases and descriptive data on the characteristics of the children and the perpetrators are presented.

前言

保護兒童資料系統由社會福利署(社署)家庭及兒童福利科負責管理，並自 1994 年 6 月起開始電腦化。該系統的功能包括個案登記、個案查詢，以及提供曾經受到傷害／虐待或現正面對遭受傷害／虐待風險的兒童，其已登記個案的統計資料。社署及非政府機構轄下服務單位均可向保護兒童資料系統登記所處理的個案。經檢討及修訂保護兒童資料系統資料輸入表格後，系統於 2022 年 9 月已進一步提升，以收集更多有關個案的資料。

保護兒童資料系統統計報告自 1996 年起每年發表，以提供該年內曾經受到傷害／虐待或現正面對遭受傷害／虐待風險的兒童所登記個案的基本資料及人口數據。《2025 年統計報告》由兩個部分組成。第一部分是關於 2025 年的新登記個案，而第二部分是比較 2023 至 2025 年的新登記個案。每個部分均會提供個案基本資料，並就受虐兒童及傷害兒童的人的特徵提供描述數據。

1.1 General Information

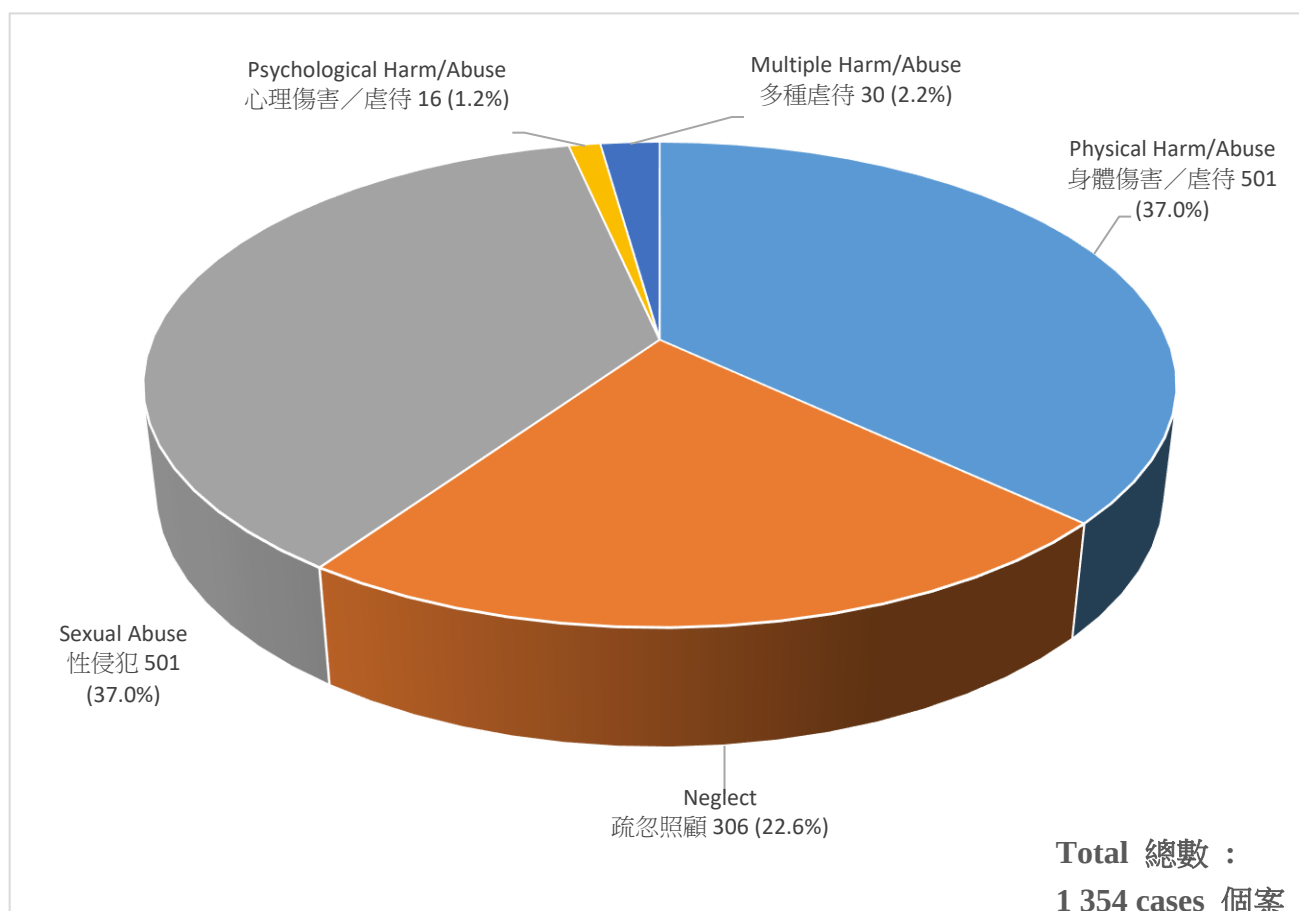
1.1.1 Types of Harm/Maltreatment

傷害／虐待類別

Among the newly registered cases in 2025, 37.0% were physical harm/abuse, 37.0% were sexual abuse, 22.6% were neglect, 2.2% were multiple harm/abuse and 1.2% were psychological harm/abuse (Graph 1).

在 2025 年的新登記個案中，37.0% 為身體傷害／虐待，37.0% 為性侵犯，22.6% 為疏忽照顧，2.2% 為多種虐待，以及 1.2% 為心理傷害／虐待(圖 1)。

1.1.2 Distribution by District 發生的地區

The three districts with the highest number of newly registered cases having the maltreatment incidents taking place were Yuen Long District (12.1%), Tuen Mun District (10.3%) and Kwun Tong District (10.0%) (Graph 2). Table 1 shows the incidence rate per 1 000 children (aged 0–17) population in different districts with the three districts having the highest incidence rate highlighted.

在新登記個案中，發生最多虐兒事件的 3 個地區分別是元朗區(12.1%)、屯門區(10.3%)和觀塘區(10.0%)(圖 2)。表 1 顯示各區每 1 000 名兒童人口(年齡介乎 0 至 17 歲)的虐兒事件發生率，發生率最高的 3 個地區以顏色標示。

圖 2：2025 年新登記個案的發生地區

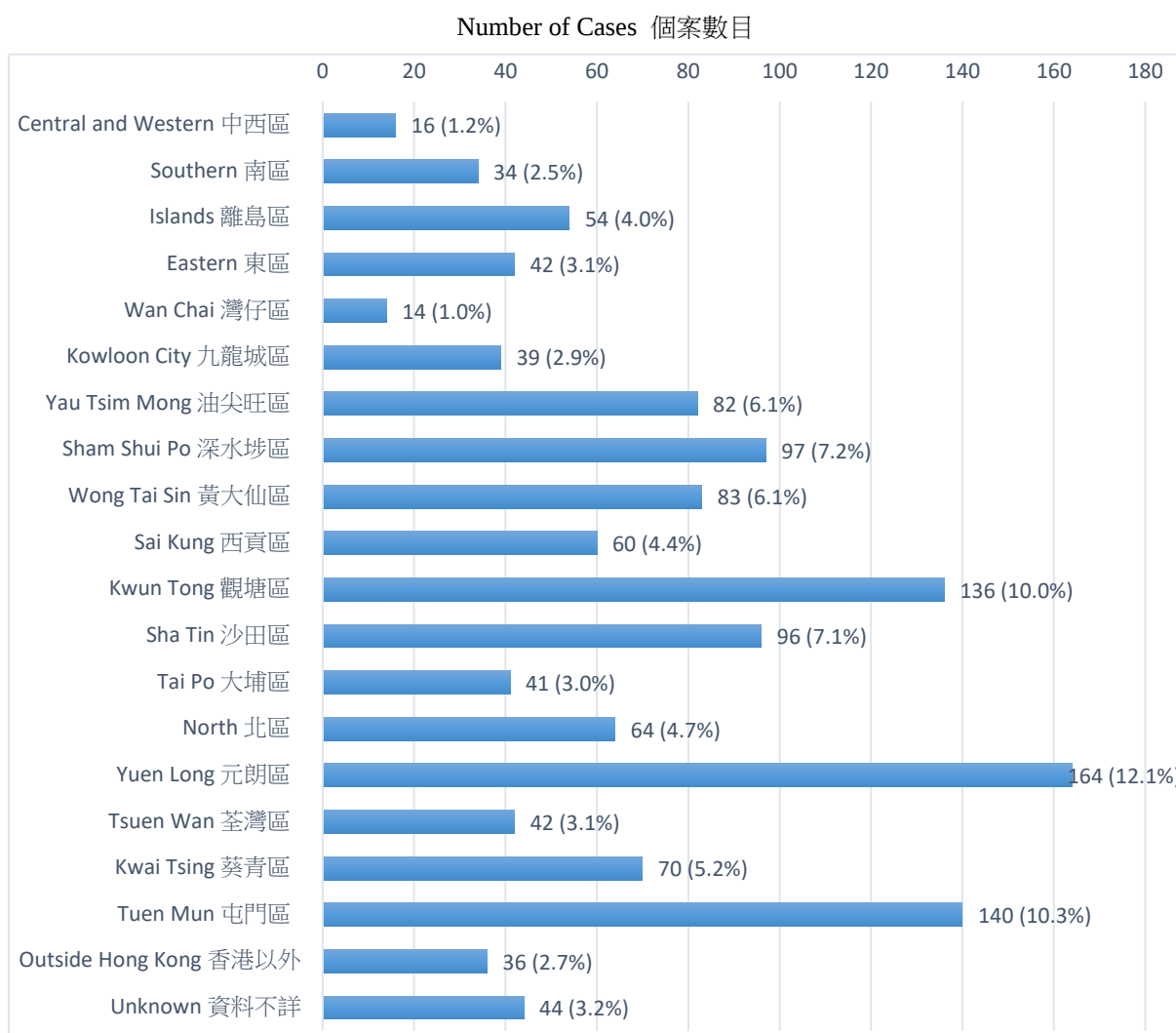

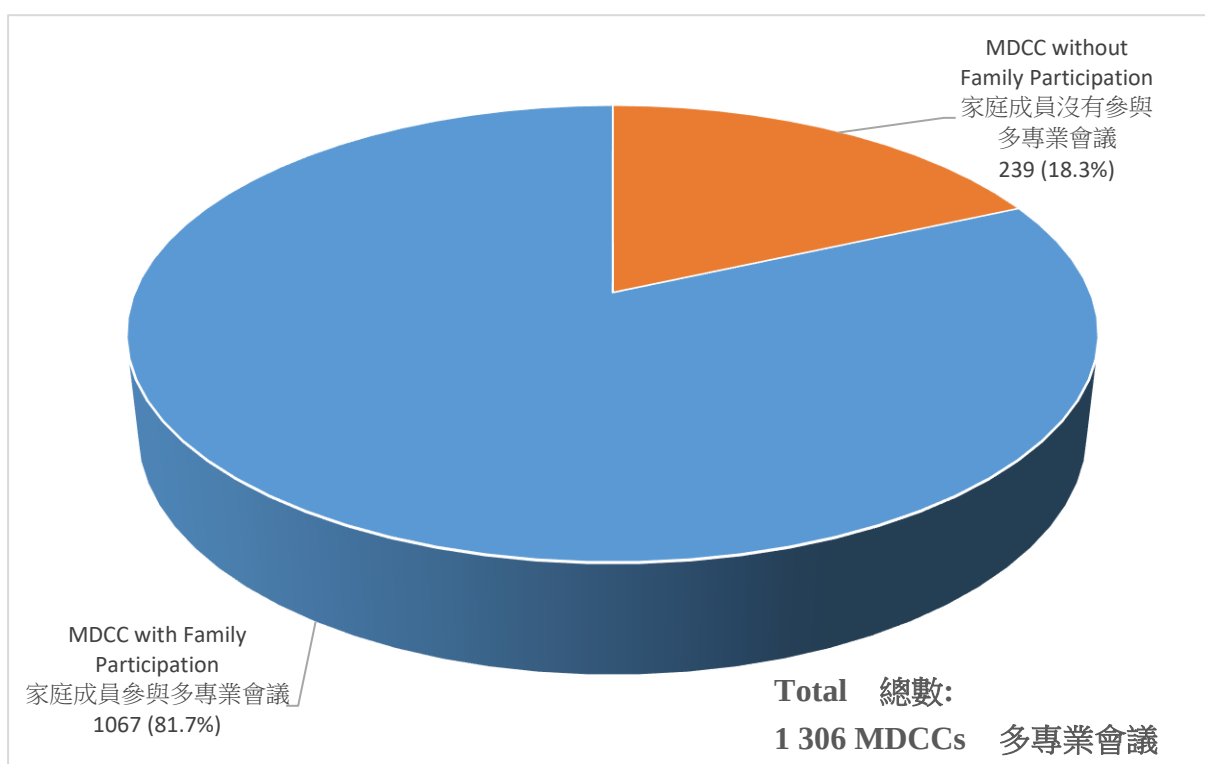

1.1.3 Multi-disciplinary Case Conference on Protection of Child with Suspected Maltreatment 保護懷疑受虐待兒童多專業個案會議

Out of the 1 354 newly registered cases, multi-disciplinary case conferences on Protection of Child with Suspected Maltreatment (MDCCs) were conducted for 1 277 cases (94.3%). A total of 1 306 MDCCs were held for discussion about the nature of the incidents, risk level and follow-up plans for these 1 277 cases. 1 067 MDCCs (81.7%) were held with family participation (Graph 3).

在 1 354 宗新登記個案中，有 1 277 宗個案(94.3%)舉行了共 1 306 次保護懷疑受虐待兒童多專業個案會議(多專業會議)，以討論該等個案的性質、風險程度及跟進計劃。其中 1 067 次多專業會議(81.7%)有家庭成員參與(圖 3)。

1.1.4 Risk Factors of Child Maltreatment at the Time of Identification/Disclosure/Investigation and Assessment 在識別／揭露／調查及評估個案期間虐兒事件的風險因素

There may be circumstances giving rise to a number of risk factors which were observed when child maltreatment was identified/disclosed/investigated. These circumstances were categorised into four subgroups, i.e. (a) factors relating to child/children; (b) factors relating to perpetrator(s); (c) factors relating to environmental or social circumstances; and (d) factors relating to the precipitating incident. The list of circumstances under each subgroup is appended below:

在識別／揭露／調查及評估虐兒事件時所察覺的多項風險因素或由不同情況引致。該等情況可分為 4 個分組，即(a) 與兒童有關的因素；(b) 與傷害的人有關的因素；(c) 與環境或社會狀況有關的因素；以及(d) 與引發事件有關的因素。各分組所涵蓋的情況載列如下：

The information of 2025 indicated that a larger proportion (65.3%) of the cases having risk factors relating to child/children, followed by factors relating to perpetrator(s) (Table 2). Table 3a shows the number of cases with the risk factors relating to child/children. Table 3b shows the number of cases with the risk factors relating to perpetrator(s). Table 3c shows the number of cases with the risk factors relating to environmental or social circumstances. Table 3d shows the number of cases with the risk factors relating to the precipitating incident.

2025 年的資料顯示有較多個案(65.3%)的風險因素與兒童有關，其次是與傷害兒童的人有關的因素(表 2)。表 3a 顯示風險因素與兒童有關的個案數目。表 3b 顯示風險因素與傷害兒童的人有關的個案數目。表 3c 顯示風險因素與環境或社會狀況有關的個案數目。表 3d 顯示風險因素與引發事件有關的個案數目。

1.2 Characteristics of Children 兒童的特點

1.2.1 Distribution of Children by Sex 兒童的性別

There were more girls (61.1%) than boys (38.9%) among the newly registered cases in 2025 (Graph 4). Table 4 shows the Distribution of Newly Registered Cases and Incidence Rate by Sex.

在 2025 年新登記個案中，女童數目(61.1%)較男童(38.9%)多(圖 4)。表 4 顯示按性別劃分的新登記個案數目及虐兒事件發生率。

圖 4 – 2025 年按兒童性別劃分個案數目

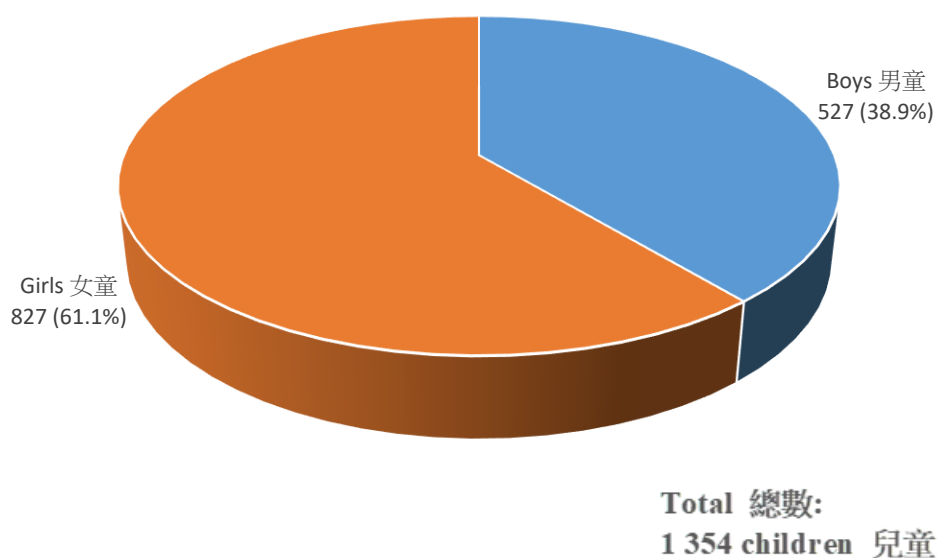

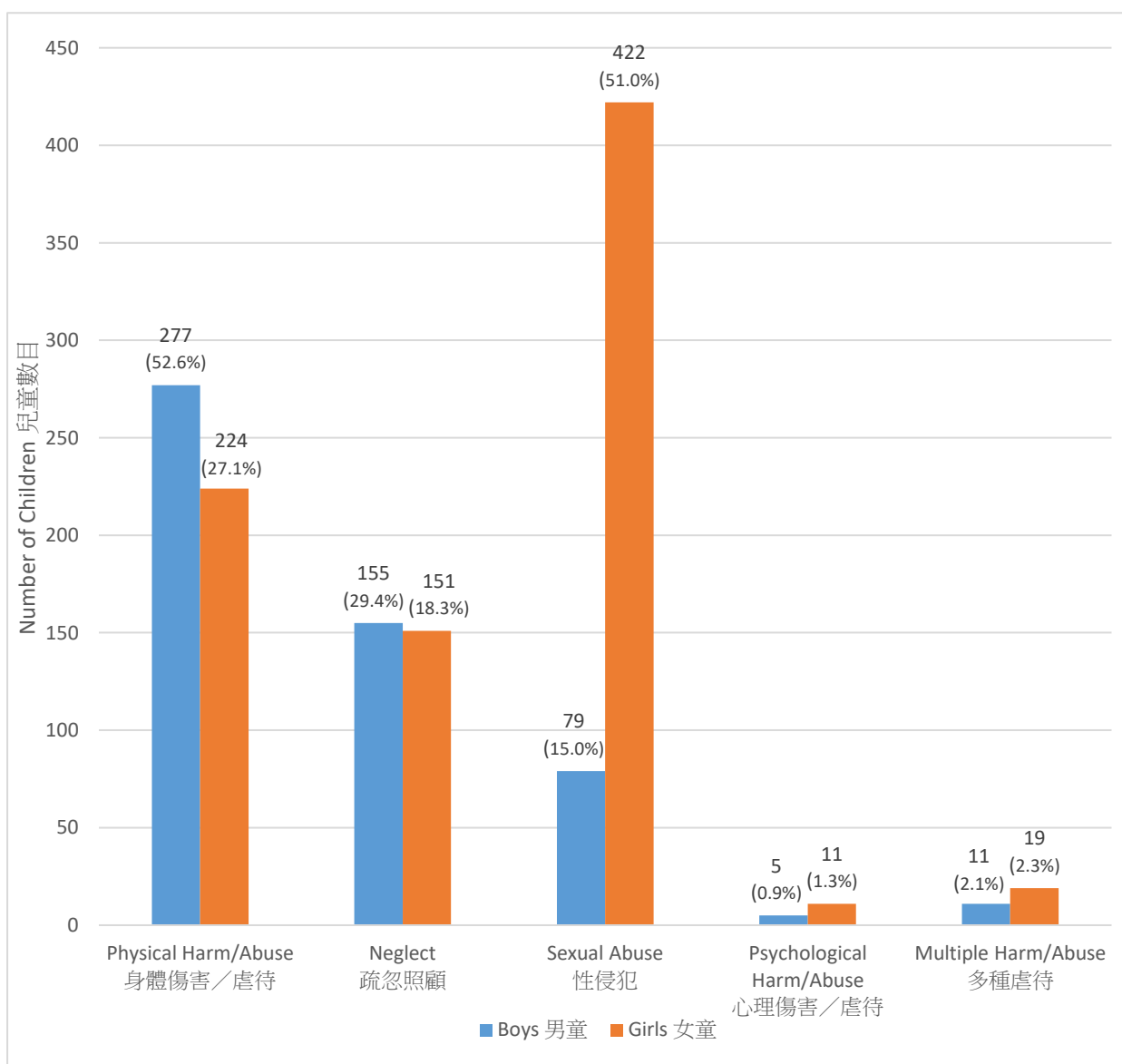

A breakdown of the sex of children by types of harm/maltreatment indicated that girls have a higher proportion in sexual abuse cases, accounting for 51.0% of the total number of girls, whereas boys have a higher proportion in physical harm/abuse cases, accounting for 52.6% of the total number of boys (Graph 5).

按傷害／虐待類別分析兒童性別分項數字顯示，女童在性侵犯個案的比例較高，佔整體女童總數 51.0%；而男童則在身體傷害／虐待個案的比例較高，佔整體男童總數 52.6% (圖 5)。

1.2.2 Distribution of Children by Age 兒童的年齡

圖 6 – 2025 年按年齡劃分兒童人數

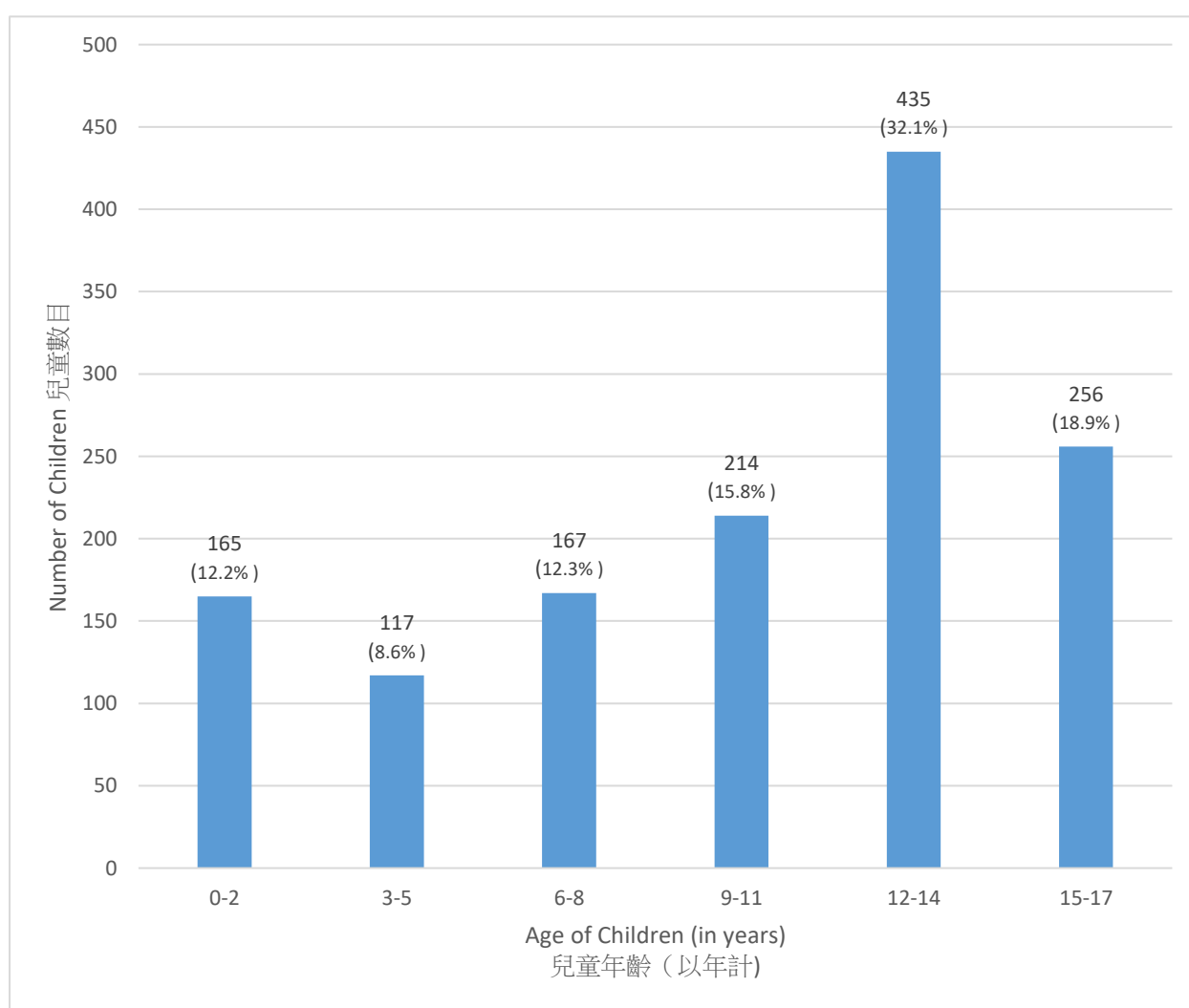

1.2.4 Ethnicity of Children 兒童種族

According to the figures on the ethnicity of children newly registered in 2025, most children (88.0%) were Chinese while the total number of children of the six ethnic minorities, including Filipino, Indian, Indonesian, Nepalese, Pakistani and Thai, is 53 (3.9%) in 2025 (Table 8).

1.2.5 Distribution of Children by Types of Children's Disabilities and by Types of Harm/Maltreatment

兒童殘疾及傷害／虐待類別

Among the 1 354 newly registered cases in 2025, 40.1% (543 cases) of the children were reported to have one or more than one type of disability. 15.7% (212 cases) of the children were reported to have Attention Deficit /Hyperactivity Disorder (ADHD). 9.7% (132 cases) of the children were reported to have Autism Spectrum Disorder while 8.4% (114 cases) of the children were reported to have Mental Illness (Table 9).

在 2025 年的 1 354 宗新登記個案中，40.1% (543 名) 兒童有一項或多於一項殘疾；15.7% (212 名) 兒童患有專注力不足過度活躍症；9.7% (132 名) 兒童有自閉症譜系障礙；另有 8.4% (114 名) 兒童患有精神病(表 9)。

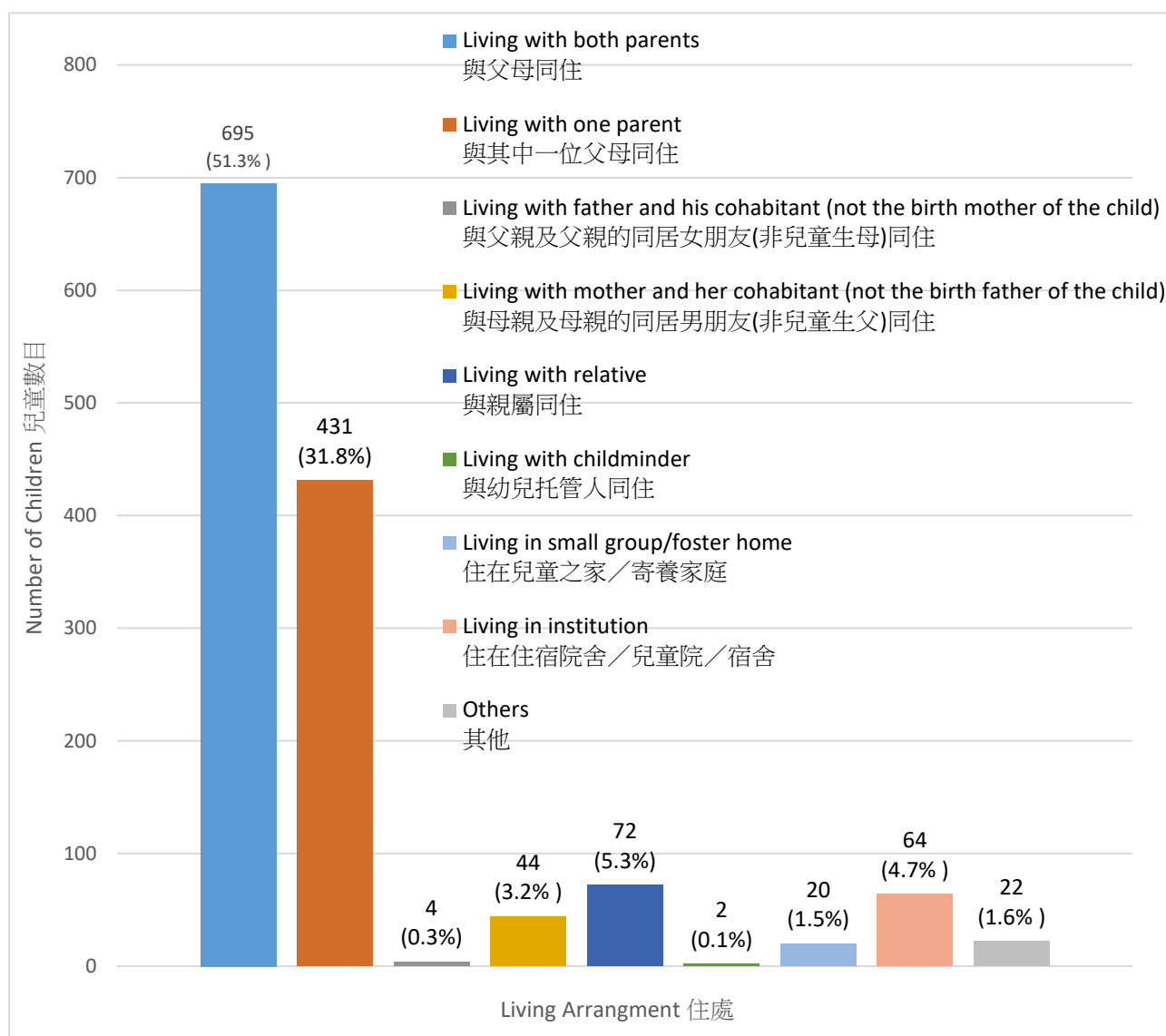

1.2.6 Living Arrangement of Children 兒童的住處

Among the 1 354 newly registered cases, 86.7% of the children were living with both parents, one parent, or one parent with their cohabitant. 6.2% of them were living in residential child care services including small group homes /foster homes /institutions at the time of the maltreatment /suspected maltreatment (Graph 7).

在 1 354 宗新登記個案中，86.7% 的受虐兒童與雙親／父母其中一方／父母其中一方及其同居伴侶同住；而 6.2% 的兒童在受虐／懷疑受虐時正接受兒童住宿照顧服務，包括兒童之家、寄養家庭及住宿院舍(圖 7)。

1.3 Characteristics of Perpetrators 傷害兒童的人的特點

There were 1 354 children and 1 395 perpetrators involved in the 2025 newly registered cases. The total number of perpetrators did not equal to the total number of children as one perpetrator might have harmed/maltreated one or more than one child(ren) whereas one child could be harmed/maltreated by one or more than one perpetrator(s).

2025 年新登記的個案涉及 1 354 名兒童和 1 395 名傷害兒童的人。由於一名傷害兒童的人有可能傷害／虐待一或多於一名兒童，而一名兒童有可能被一或多於一名傷害兒童的人傷害／虐待，故傷害兒童的人的總數與受虐兒童總數並不相同。

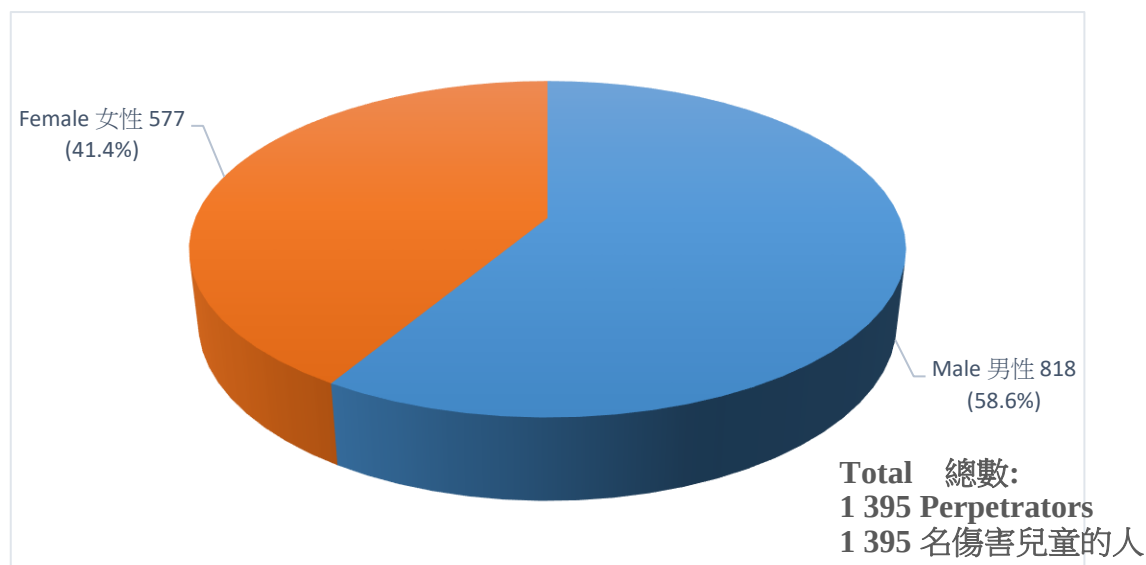
1.3.1 Distribution of Perpetrators by Sex 傷害兒童的人的性別

There were more male perpetrators (818 persons, accounting 58.6% of the total number of perpetrator) than female perpetrators (577 persons, accounting 41.4% of the total number of perpetrator) in the 2025 newly registered cases (Graph 8). Male perpetrators more involved in sexual abuse cases, accounting 58.4% of the total number of male perpetrators. Meanwhile, female perpetrators more involved in neglect and physical harm/abuse cases, accounting 45.9% and 42.1% of the total number of female perpetrators respectively (Graph 9).

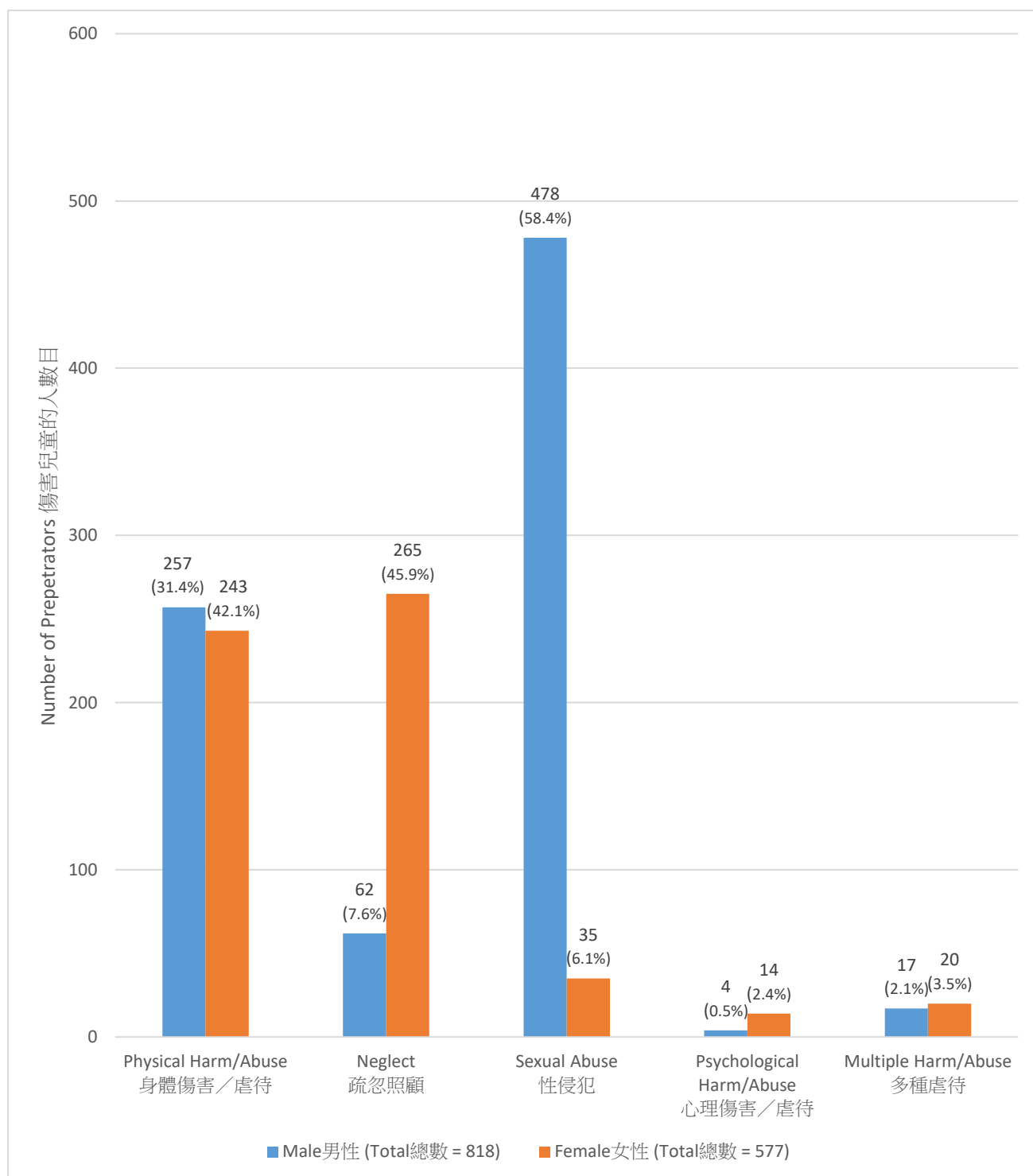
在 2025 年，男性傷害兒童的人(818 人，佔總傷害兒童的人總數 58.6%)較女性傷害兒童的人(577 人，佔總傷害兒童的人總數 41.4%)多(圖 8)。男性傷害兒童的人多涉及性侵犯個案，佔男性傷害兒童的人總數 58.4%。女性傷害兒童的人則較多涉及疏忽照顧和身體傷害／虐待個案，分別佔女性傷害兒童的人總數 45.9%和 42.1%(圖 9)。

1.3.2 Distribution of Perpetrators by Age 傷害兒童的人的年齡

Excluding the number of “Unknown”, the age group between 32 and 46 years old represents the highest number of perpetrators in the 2025 child protection cases, accounting for 40.1% of the total number of perpetrators (Graph 10). The highest numbers of perpetrators of sexual abuse and physical harm/abuse come from the age groups of 16 or below and 42 to 46, accounting for 23.0% and 24.6% of the total number of perpetrators for the concerned type of harm/maltreatment respectively. Table 10 shows the distribution of perpetrators of different age groups by types of harm/maltreatment with the highest number highlighted.

在 2025 年新登記個案中，撇除「資料不詳」的數目，年齡介乎 32 至 46 歲組別在傷害兒童的人中為最多，佔總傷害兒童的人總數 40.1% (圖 10)。而 16 歲或以下和 42 至 46 歲這兩個年齡組別在性侵犯和身體傷害／虐待個案中為最多數，分別佔該虐待類別中傷害兒童的人總數 23.0% 及 24.6%。表 10 顯示按傷害／虐待類別劃分不同年齡組別的傷害兒童的人的人數，並以顏色標示人數最多的組別。

圖 10 – 2025 年傷害兒童的人的年齡

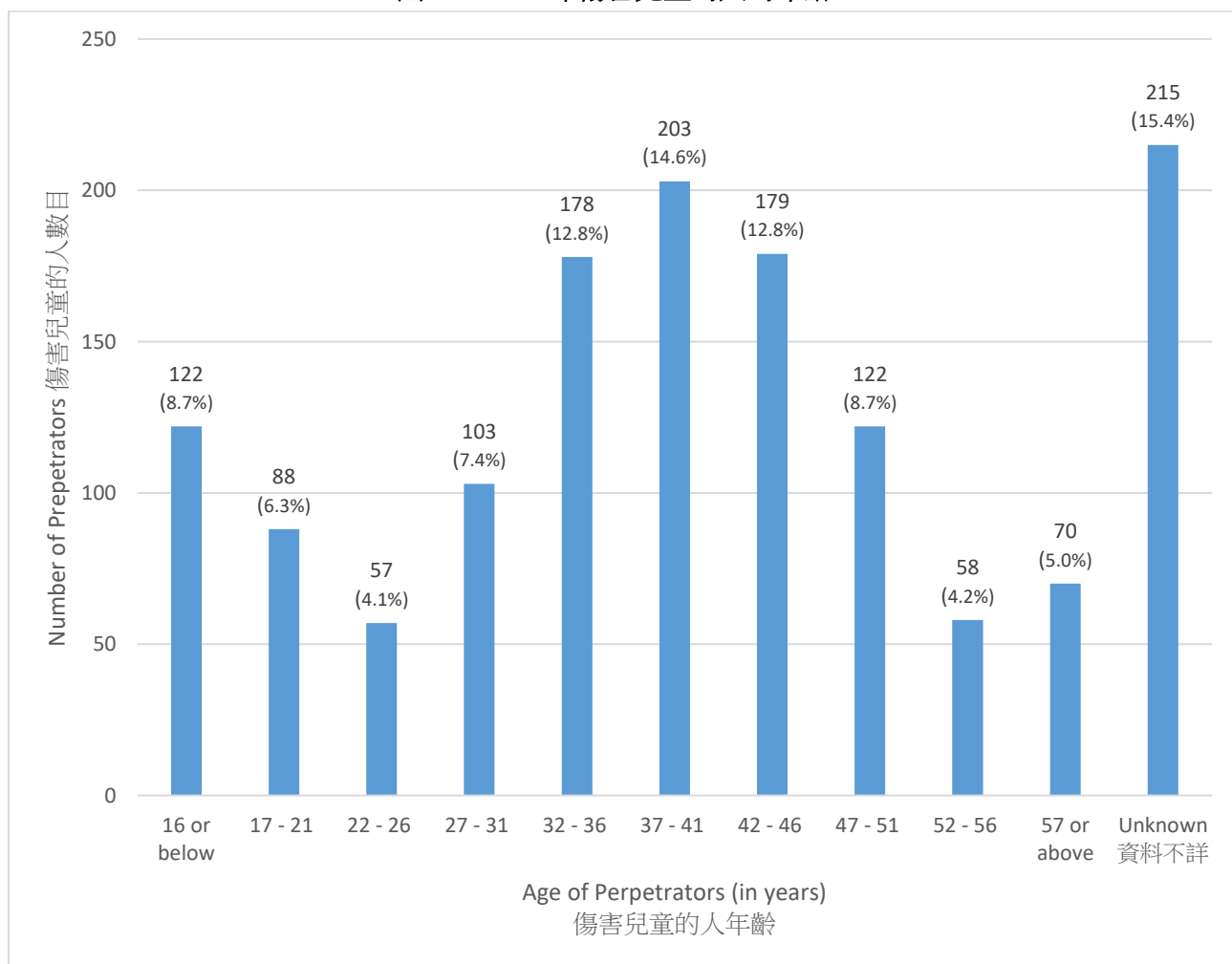

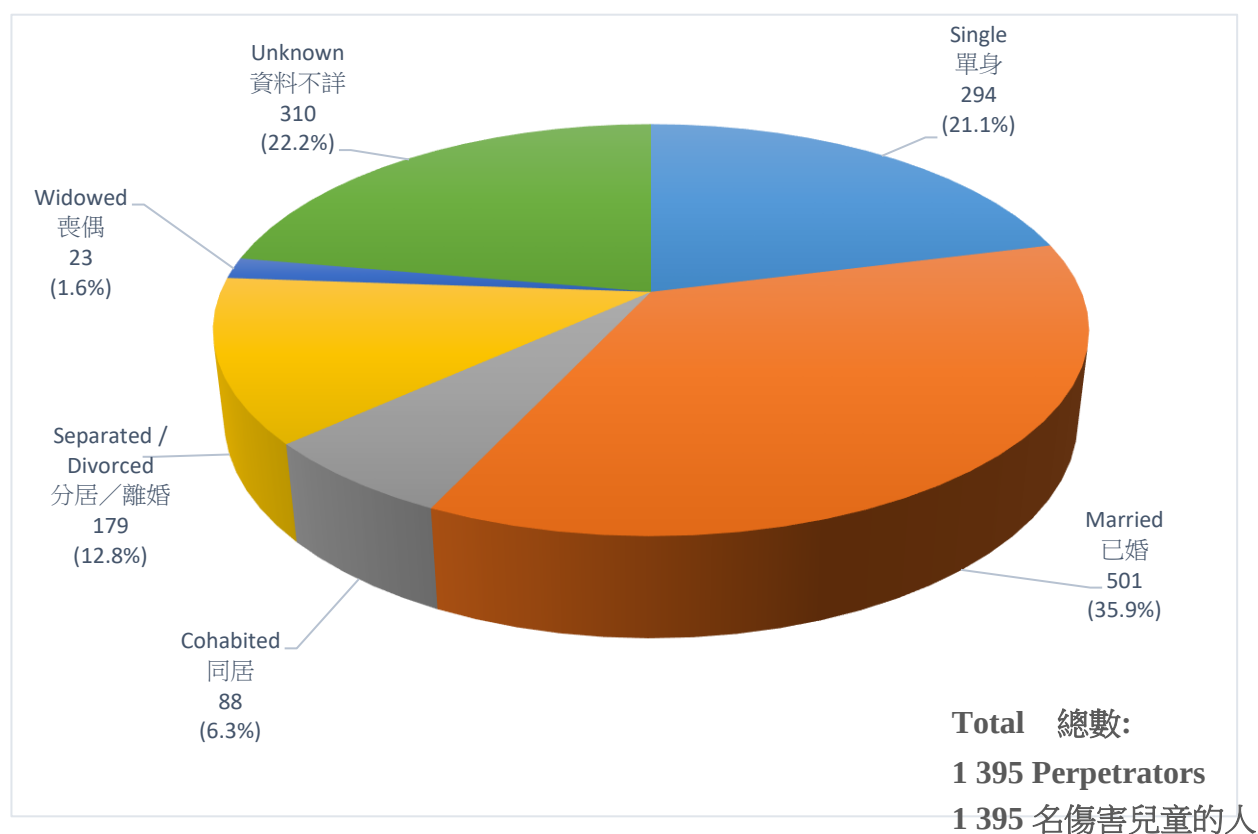
1.3.4 Marital Status of Perpetrators 傷害兒童的人的婚姻狀況

35.9% of the 1 395 perpetrators of 2025 newly registered cases were married, accounting for the majority of the total number of perpetrators. As some of the perpetrators, particularly for sexual abuse cases, could not be identified or were unrelated persons, the marital status of a certain proportion of the perpetrators was unknown (Graph 11).

在 2025 年新登記個案的 1 395 名傷害兒童的人中，有 35.9% 屬已婚，佔傷害兒童的人總數的大多數。由於部分傷害兒童的人(特別是性侵犯個案)的身分為未能識別，又或者傷害兒童的人屬沒有關係人士，有一定比例的傷害兒童的人的婚姻狀況列為「資料不詳」(圖 11)。

圖 11 – 2025 年傷害兒童的人的婚姻狀況



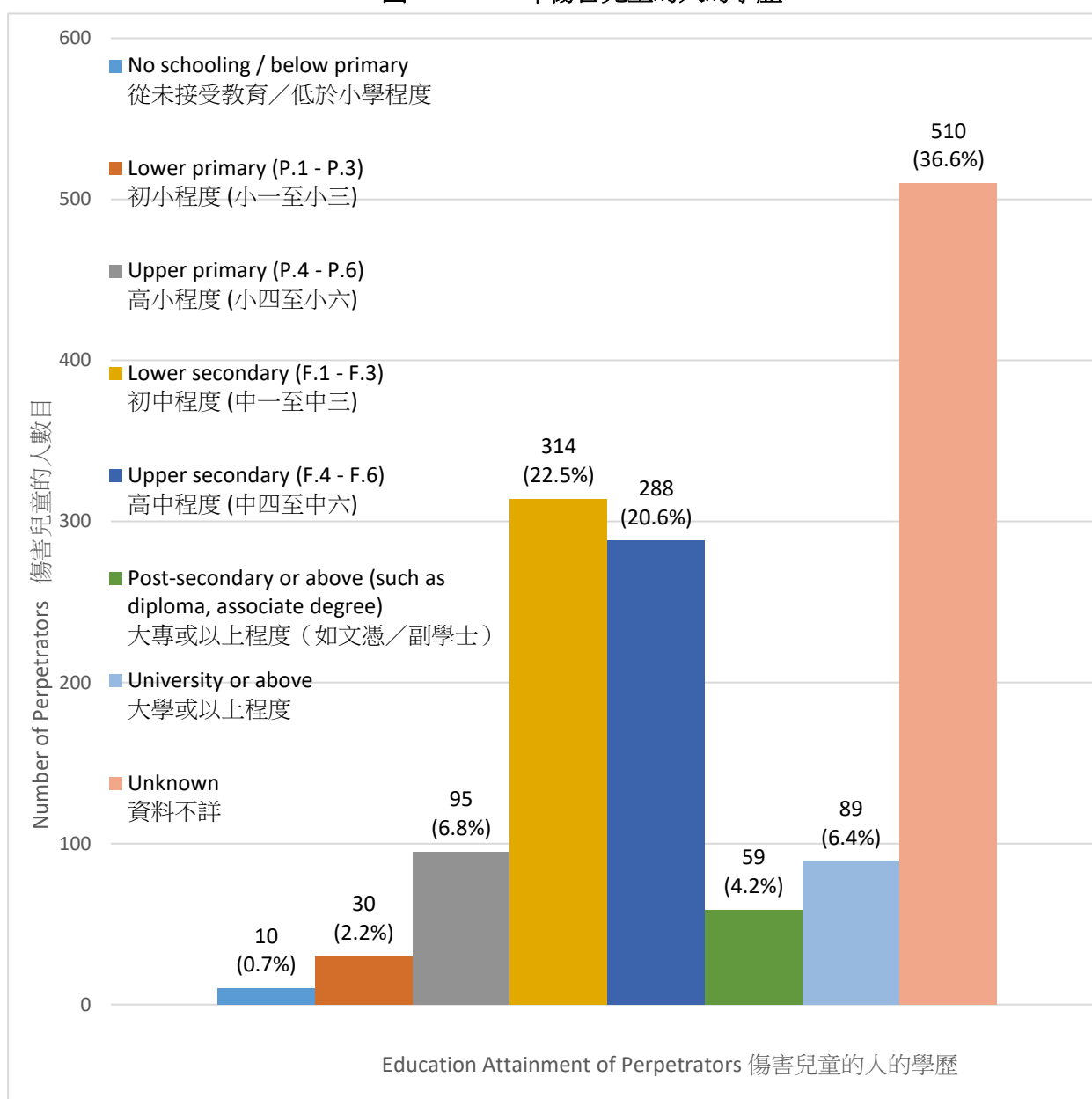
1.3.5 Educational Attainment of Perpetrators 傷害兒童的人的學歷

In 2025, 32.2% of the perpetrators of the newly registered cases were of lower secondary education standard or below. As some of the perpetrators, particularly for sexual abuse cases, could not be identified or were unrelated persons, the educational attainment of a certain proportion of the perpetrators was unknown (Graph 12).

圖 12 – 2025 年傷害兒童的人的學歷



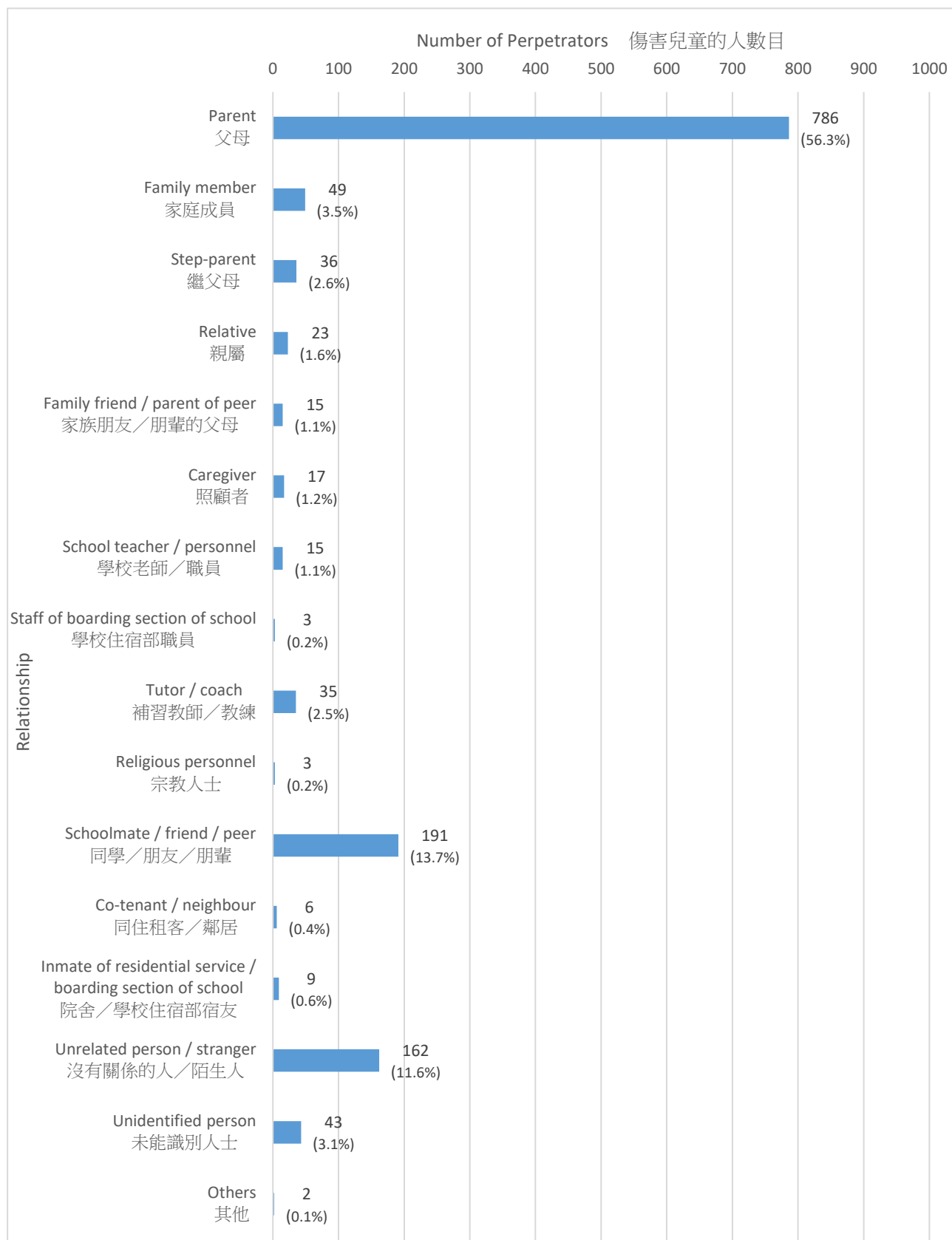
1.3.6 Relationship of Perpetrators and Children 傷害兒童的人與受虐兒童的關係

56.3% of the perpetrators involved in the newly registered cases were parents of the children (Graph 13). In Table 13, the relationship of perpetrators and children with the highest number of cases for each type of harm/maltreatment are highlighted. Among the 513 perpetrators involved in sexual abuse, 37.2% of them were schoolmates /friends /peers whereas majority of perpetrators of the other three types of harm/maltreatment were parents of the children.

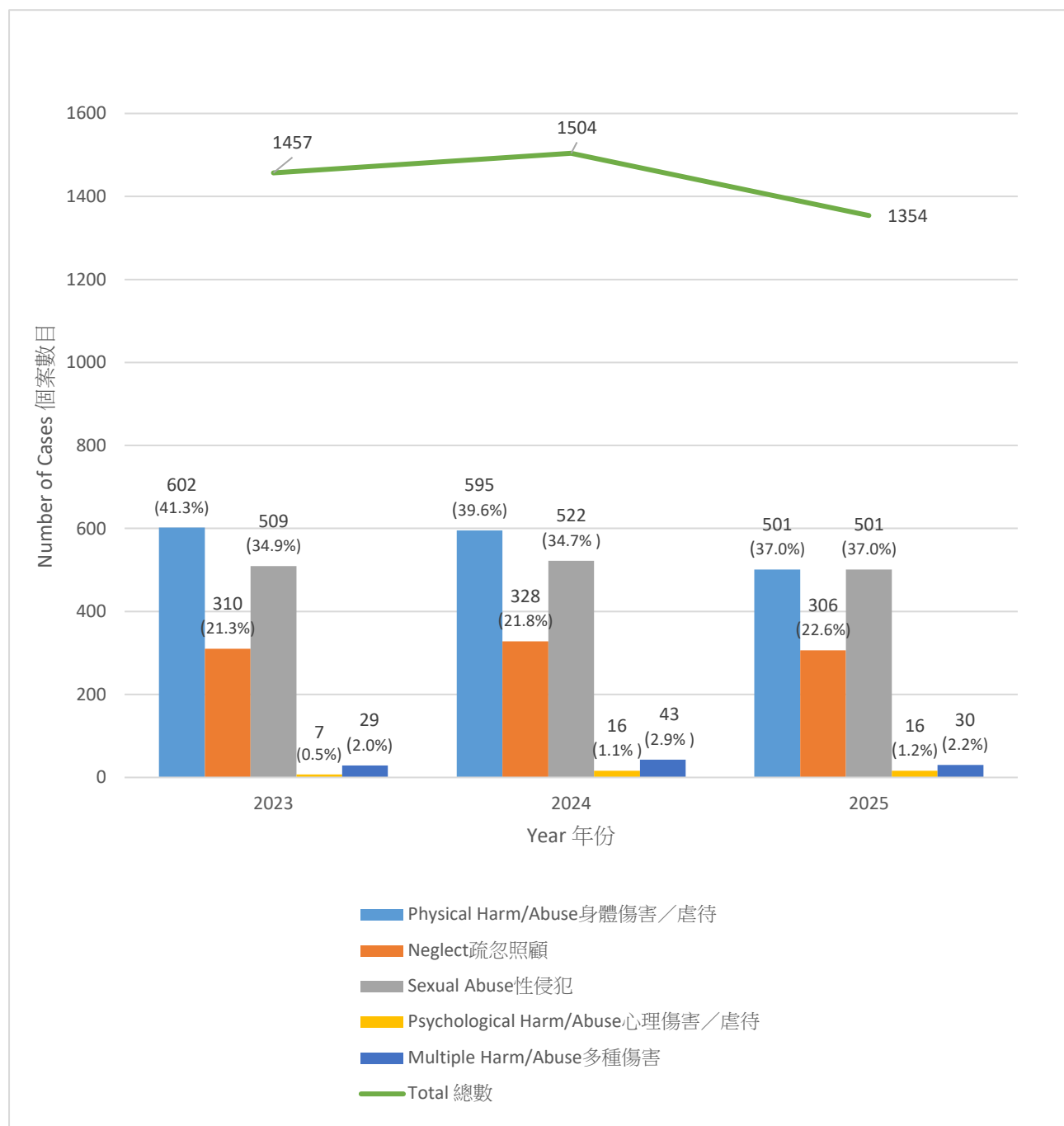

Appendix

Glossary

This annual report follows the glossary of “Protecting Children from Maltreatment – Procedural Guide for Multi-disciplinary Co-operation (Revised 2026)” (Procedural Guide 2026) implemented with effective from 20 January 2026.

Child Abuse / Child Maltreatment (definition) In a broad sense, child maltreatment is defined as any act of commission or omission that endangers or impairs the physical/psychological health and development of an individual under the age of 18. Child maltreatment is committed by individuals, singly or collectively, who by their characteristics (e.g. age, status, knowledge, organisational form) are in a position of differential power that renders a child vulnerable.

Types

- **Physical Harm/Abuse**

This refers to physical injury or suffering inflicted on a child by violent or other means (e.g. punching, kicking, striking with an object, poisoning, suffocation, burning, shaking an infant or Factitious Disorder Imposed on Another¹), where there is a definite knowledge, or a reasonable suspicion that the injury has been inflicted non-accidentally.

- **Neglect**

This refers to a severe or repeated pattern of lack of attention to a child’s basic needs that endangers or impairs the child’s health or development.

- (a) Physical neglect includes failure to provide necessary food/clothing/shelter, failure to prevent physical injury/suffering, lack of appropriate supervision, leaving a young child unattended, improper storage of dangerous drugs resulting in accidental ingestion by a child or allowing a child to stay in a drug-taking environment resulting in inhalation of the dangerous drugs by a child. Drug/alcohol abuse during pregnancy can affect the health and development of an infant. If a pregnant woman fails to receive treatment for drug /alcohol abuse or make every effort to reduce her drug/alcohol use during pregnancy resulting in signs of poisoning (e.g. being tested positive for dangerous drugs or alcohol) of the newborn or withdrawal symptoms for dangerous drug or alcohol of the infant, these cases may be handled as suspected neglect; or

¹ Factitious Disorder Imposed on Another, formerly known as Munchausen’s Syndrome by Proxy, occurs when a parent or guardian falsifies physical and psychological signs or symptoms of a child, or induction of injury or disease to a child, or causes a child to receive innumerable unnecessary hospital treatments through other deceitful conducts (e.g. alters a child’s laboratory test report) (Ref.: American Psychiatric Association. (2013). Diagnostic and Statistical Manual of Mental Disorders (5th Edition).)

- (b) Medical neglect includes failure to provide necessary medical or mental health treatment to a child; or
- (c) Educational neglect includes failure to provide education or ignoring the educational/training needs arising from a child's disability².

- **Sexual Abuse**

This refers to forcing or enticing a child to take part in any acts of sexual activity for sexual exploitation or abuse and the child does not consent to or fully understand or comprehend this sexual activity that occurs to him/her due to mental immaturity.

This sexual activity includes behaviours that have or do not have direct physical contact with children (e.g. rape, oral sex, procuring a child to masturbate others/exposing his/her sexual organs, or posing in an obscene way/watching sexual activities of others, production of pornographic material, forcing a child to engage in prostitution, etc.).

Sexual abuse may be committed inside or outside the home or through social media on the internet by perpetrators acting individually or in an organised manner. It includes luring a child through rewards or other means for abuse, including sexual grooming, which refers to designedly establish a relationship/an emotional connection with a child by various means for gaining his/her trust with an intent to sexually abuse him/her (e.g. communicating with a child through mobile phone or the Internet).

Consensual sexual activity between an adolescent and another person may also involve sexual exploitation by a person whose characteristics are in a position of differential power to the adolescent. Cases where the adolescent is not mentally mature, too young (e.g. under the age of 13) or the sexual activity leads to sexually transmitted diseases ("STDs") or pregnancy may be handled as suspected sexual abuse³.

² According to the "Disability Discrimination Ordinance Code of Practice on Education", the provisions of the "Disability Discrimination Ordinance" apply to a wide range of persons, including those usually referred to as persons with intellectual disability or mental handicap, autism spectrum disorder, specific learning disabilities, hearing impairment, visual impairment, physical disability or handicap, mental illness and various other chronic illnesses, and persons who are infected with the human immunodeficiency virus (commonly known as "HIV-positive") or who have acquired immune deficiency syndrome (commonly known as "AIDS").

³ The younger the age, the more vulnerable a juvenile is even he/she is involved in a consensual sexual activity (With reference made to Section 123 "Intercourse with Girl under 13" of "Crimes Ordinance", Cap 200, its maximum penalty is higher than the one of Section 124 "Intercourse with Girl under 16"). As STDs or pregnancy resulting from sexual activity will affect the juvenile physiologically and psychologically, personnel should first conduct an initial assessment to identify if there is a reason to believe or suspect the juvenile is harmed/maltreated where cases involved juvenile engaging in a consensual sexual activity being under the age of 13 or having STDs or pregnancy resulting from unsafe sex. Personnel should also take child protection and related investigation as appropriate.

- **Psychological Harm/Abuse**

This refers to a repeated pattern of behaviour and/or interaction between carer and child, or an extreme incident that endanger(s) or impair(s) the child's physical and psychological health (including emotional, cognitive, social and physical development).

- **Multiple Harm/Abuse**

Combination of more than one of the above four types of harm/maltreatment.

Case One case refers to one child.

Newly Registered Cases Newly registered cases include cases involving children having been harmed/maltreated or currently at risk of harm/maltreatment.

附錄

詞彙表

本年報採用自 2026 年 1 月 20 日生效的《保護兒童免受虐待—多專業合作程序指引》(2026 年修訂版)(《2026 年程序指引》)的詞彙表。

傷害／虐待兒童(定義) 廣泛而言，虐待兒童是指對十八歲以下人士作出／不作出某行為以致兒童的身心健康發展受危害或損害。虐待兒童是指人們(單獨或集體地)利用本身與兒童之間權力差異的特殊地位(例如年齡／知識／組織形式)使兒童處於一個易受傷害的境況而作出的。

種類

- **身體傷害／虐待**

指對兒童使用暴力或以其他方式令兒童身體受傷或痛苦(例如拳打腳踢、以物件擊打、下毒、使窒息、灼傷、搖盪嬰兒或照顧者假裝兒童生病求醫¹等)，而且有明確的資料可以肯定或合理地懷疑這些傷害並非意外造成的。

- **疏忽照顧**

指嚴重或重複地忽視兒童的基本需要，以致危害或損害兒童的健康或發展。

- ✧ **身體方面**

- ◆ 包括沒有給予兒童必需的飲食／衣服／住所、沒有避免兒童身體受傷／受痛苦、缺乏適當看管兒童、獨留年幼兒童不顧、沒有適當儲存危險藥物而令兒童誤服或讓兒童身處吸食危險藥物的環境，以致兒童吸入危險藥物。
- ◆ 孕婦於懷孕期間濫用藥物／酒精可能令嬰兒的健康及成長受影響。如有關孕婦在懷孕期間沒有接受濫藥／戒酒治療或盡力減低其濫用藥物／酒精的次數，以致嬰兒出生時身體呈現中毒跡象(例如身體驗出危險藥物或酒精)或嬰兒呈現危險藥物或酒精的脫癮癥狀，可被視為懷疑疏忽照顧處理；或

¹ 照顧者假裝兒童生病求醫，以往稱為 Munchausen Syndrome by Proxy，指兒童的父母或監護人虛構兒童在身體或心理上的病徵、或實際導致其患病或受傷、或藉其他欺騙行為(例如竄改其化驗報告)，令兒童因而可能需要多次接受不必要的醫院療程。

✧ 醫療方面：

- ◆ 包括沒有讓兒童接受必須的醫療或精神治療；或

✧ 教育方面：

- ◆ 包括沒有讓兒童接受教育，或忽視因兒童的殘疾²而引起的教育／訓練需要。

- 性侵犯

指強逼或誘使兒童參與性活動，以對兒童作出性方面的利用或侵犯，而兒童並不同意或因心智發展未成熟而不能完全明白或理解發生在他／她身上的這些性活動。

這些性活動包括與兒童有直接身體接觸或沒有身體接觸的行為(例如強姦、口交、促使兒童為他人手淫／展示其性器官或作淫褻姿勢／觀看其他人的性活動、製作色情物品、強逼兒童從事賣淫活動等)。

性侵犯可能發生在家中或其他地方，或透過網上社交平台，以個別或有組織的方式進行，包括以獎賞或其他方式引誘兒童加以侵犯，亦包括為性目的誘識兒童，即有計劃地透過不同方法(例如藉流動電話或互聯網與兒童通訊)與兒童建立關係及／或情感聯繫，以博取兒童的信任，意圖對他們作出性侵犯。

少年人自願或同意與他人進行性活動亦有可能是有人利用本身與少年人之間權力差異的特殊地位而對少年人在性方面作出利用。若相關的少年人心智發展未成熟、年齡太小(例如小於 13 歲)或因性行為導致染上性病或懷孕，可被視為懷疑性侵犯處理³。

² 根據《殘疾歧視條例教育實務守則》，《殘疾歧視條例》保障的殘疾人士類別極其廣泛，包括一般被稱為智障或弱智、自閉症譜系障礙、特殊學習障礙、聽障、視障、肢體傷殘、精神病人及各種長期病患者，以及後天免疫力缺乏症病毒(常稱為「愛滋病病毒」)感染者或後天免疫力缺乏症(常稱為「愛滋病」)患者等。

³ 即使少年人自願或同意與他人進行性活動，但少年人年紀愈小便愈容易受傷害（參考香港法例《刑事罪行條例》（第 200 章）第 123 條「與年齡在 13 歲以下的女童性交」的最高刑罰比第 124 條「與年齡在 16 歲以下的女童性交」為高）。因性行為導致染上性病或懷孕亦會令少年人身心受影響。因此，為加強保護此類少年人，若自願與他人進行性活動的少年人小於 13 歲或因進行性行為時未有採取安全措施而導致染上性病或懷孕，工作人員應先進行初步評估，辨識是否有理由相信或懷疑少年人受到傷害／虐待，並按需要作出保護兒童及其他相關調查。

- **心理傷害／虐待**

指危害或損害兒童身心健康(包括兒童的情緒、認知、社交或身體發展)的重複的行為及／或照顧者與兒童之間的相處模式；或極端事件。

- **多種傷害／虐待**

指在上述 4 類傷害／虐待行為中，同時作出多於 1 類傷害／虐待行為。

一宗個案指一位兒童

新登記個案

新登記個案包括兒童曾經受到傷害／虐待或現正面對遭受傷害／虐待的風險。
