5. This licence is valid for 36 months effective from the date of issue to cover the period from 1 January 2022 to 31 December 2024 inclusive.

6. This licence is issued subject to the following conditions –

comply with section 11(1A) of the Residential Care Homes (Elderly Persons) Regulation (Cap. 459A) concerning the employment of staff; and

- (ii) the operator shall comply with the Code of Practice for Residential Care Homes (Elderly Persons) (Nursing Home) issued by DSW for the operation, keeping, management or other control of its
nursing home places as specified in (i) above.

7. This licence may be cancelled or suspended in exercise of the powers vested in me under Section 10 of the Residential Care Homes (Elderly Persons) Ordinance in the event of a breach of or a failure to perform any of the conditions set out in paragraph 6 above.
